


Sector Highlights

- NDT is a global industry that historically has outperformed the broader industrial market


Key Drivers


- The NDT market has displayed expansion as a result of secular growth driven by recurring maintenance spending and expansionary capital investment
- Increase in automation in the industrial manufacturing and infrastructure sectors has led to a substantial demand for flaw detection
- Increasingly stringent regulations, codes, and standards have also forced specific products to undergo non-destructive testing

2020 NDT Market Breakdown






Historical Non-Destructive Testing Transactions


